## 2024 DRAFT BUDGET:

DOLL OALL

The Board was provided a draft budget based on actual expenditures for the first 9 months of the year. A majority of the line items remain the same as 2023 but there were a few items that needed to be increased. The most significant increase was for the 2024 insurance. Greg Waltz with Mack, Mack and Waltz was present to provide an overview of the insurance situation.

**INSURANCE UPDATE:** IN 2023 there has been \$93 Billion in losses due to weather/ climate events. The united Stated accounted for 74% fo all global losses through September. From 2018 through 2022, there was an average of eighteen (18) One billion events each year compared to the historic average of \$8.5 per year since 1990. These climate-fueled intense natural disasters leads to higher insurance costs, as well as more difficulty in obtaining insurance.

Ten insurance companies went out of business in Florida wince 2021. Nationwide Florida has 9% of all property claims however 79% of lawsuits are against insurers.
