APPROVAL OF PRIOR MEETING MINUTES

Normal Paul made a motion to approve the Special Assessment meeting minutes from April 12, 2023. Dominick Mimeault seconded the motion. As there were no objections, the motion passed unanimously.

Normal Paul made a motion to approve the April 12, 2023, Board of Directors Meeting Minutes. Ray McLellan seconded the motion. As there were no objections, the motion passed unanimously.

APPROVAL OF FINANCIALS

Cash in the operating account showed at \$121,124.12. Cash in the reserve account showed at \$219,808.72. Total actual expenses for the month were \$120,261.08 while the association budgeted \$112,367.07 for the month leaving a net loss of -\$7,894.01 for the month (due to insurance increase).

Year to date the association expenses total \$1,214,602.35 while the association budgeted \$1,123,670.70 leaving a net loss of -\$90,931.65 for the year. A motion was made by Yvon Letourneau to approve the October financial statement. Scarlette Stefanelli seconded the motion. As there were no objections, the motion passed unanimously.

UNFINISHED BUSINESS

<u>Golf Carts</u> – Three golf carts were purchased to replace the leased carts that were being used. One of the carts had to be returned. The association is in the process of negating a deal to purchase one of the leased carts.

<u>Painting Project</u> – The association made a settlement agreement with UCI Paints and Biscayne. All liens that were assessed have been removed. The association had to pay \$5,746.00 in legal fees to Scott Bender. No additional costs above the contract agreement were paid.

<u>Bylaw Amendments</u> – Due to some clerical errors on the approved bylaw amendments from April 12, 2023, Michael Goldstein advised some additional language was added (and deleted) in the draft provided. He advised the bylaws require the exact writing must be voted on. This item was tabled for further review and will be on the next month's budget for approval.

NEW BUSINESS

Raymond McLellan made a motion to ratify the prior action of approving G. Batista to provide structural integrity reserve study for Buildings A-M as required by Florida Law. The reserve studies should be available by next week. Normal Paul seconded the motion. As there were no objections, the motion passed unanimously.

PRESIDENT REPORT

Larry Fetta discussed all the accomplishments made so far in 2023.
